Milos has testified as an expert witness on human rights, supply chain and national security before the U.S. Congress and has been involved in diplomatic efforts to secure the release of American journalists persecuted and imprisoned in Africa.

Milos has furthermore strong experience **leading international arbitrations** in a wide range of industries, including mining, oil and gas, banking and finance, patent infringement, tourism, etc. His expertise includes counselling host states and international investors engaged in investor-state arbitral proceedings (e.g. under bilateral investment treaties).

He is committed to assisting new generations of legal professionals. Students under his supervision achieved significant success in leading international competitions. His academic fields of expertise are public international law, international dispute resolution and comparative civil procedure. Milos currently teaches International Criminal Law, International Migration and Asylum Law, and Human Rights at **Washington University School of Law**.

Milos supports diverse social responsibility initiatives, providing **pro bono representation in international human trafficking cases**. He serves as a board member of the Interparliamentary Taskforce on Human Trafficking.
